

# The Full Terms & Conditions.

TERMS & CONDITIONS – Alex Bronwyn MUA  
Effective as of 2016.

Thank you for choosing Alex Bronwyn MUA. We are committed to delivering a high standard of makeup artistry in a safe, respectful, and personalised environment. By securing a booking and paying a deposit, you acknowledge and accept the following Terms and Conditions.

## 1. Client Confidentiality

All personal and sensitive information provided to Alex Bronwyn MUA is treated with strict confidentiality and will not be disclosed to third parties without your explicit consent.

---

## 2. Appointment Bookings

- A 50% non-refundable deposit is required to confirm and secure your appointment.
- Upon confirmation, you will receive a message from a no-reply number.
- A reminder will be sent 72 hours (3 days) prior to your booking, which will include the appointment address.
- For any changes, please contact Alex directly via DM or text at 0449 669 802.

Please note: Alex is a mother to two young children and must arrange appropriate care in order to provide your service. This is factored into availability and booking conditions.

## 3. Online Payments & Card Security

When paying for your appointment online via our website, you may be given the option to securely save your card details for future convenience.

- Your payment information is encrypted and securely stored via a certified third-party payment gateway.
- Alex Bronwyn MUA does not have access to or store full card details.
- All transactions and stored information are managed in accordance with PCI-DSS compliance standards.
- Saving your card is optional, and you may remove it at any time.

Your privacy and payment security are a top priority, and we take all reasonable measures to ensure your information remains safe and confidential.

## 4. Cancellations & Rescheduling

We understand that plans change. However, to be fair to all clients and due to the childcare commitments involved in making each appointment possible, the following cancellation policy applies:

### Standard Bookings:

- Cancellations/rescheduling require a minimum of 24 hours' notice.
- Cancellations within 24 hours or no-shows will result in forfeiture of the 50% deposit.
- Appointments booked within 24 hours may be cancelled or changed up to 4 hours before the scheduled time to avoid forfeiture.
- If you are unwell, including symptoms of flu, cold, cold sores, rashes, or conjunctivitis, please reschedule.
- Deposits for appointments cancelled due to illness will be held as **credit** for up to 6 months.

### Group Bookings (3 or more people):

- Require 72 hours' notice for cancellation or modifications.
- Any individual who fails to attend without sufficient notice will forfeit their deposit.

### Bridal Bookings:

- Require 8 weeks' notice for cancellation or major changes.
- Less than 8 weeks' notice will incur a charge of 50% of the total service amount or forfeiture of the deposit.

## 5. Running Late or No-Shows

- Clients running 15 minutes or more late may need to have their appointment rescheduled, depending on the day's schedule.
  - If no contact is made within 15 minutes of your scheduled appointment, it will be considered a No-Show, and the deposit will be forfeited.

## 6. Health & Wellness Policy

Due to having Cystic Fibrosis, Alex must avoid contact with contagious illnesses. Please respect this and the health of other clients:

- If you are unwell, including symptoms of flu, cold, cold sores, rashes, or conjunctivitis, please reschedule.
  - Deposits for appointments cancelled due to illness will be held as credit for up to 6 months.
  - Should Alex need to cancel your booking due to illness, family emergency, or COVID restrictions, your deposit will also be held as credit for the same service and rescheduled as a priority.

## 7. Bridal & Group On-Location Setup Requirements

For services delivered on location, the following setup must be provided:

- Access to natural light (near a window or door).
  - A clean surface at least 1m x 1m in size for makeup products.
  - A bar stool per MUA is required. If unavailable, Alex can bring one with prior notice.

## 8. Invoices & Payments

- Alex Bronwyn MUA and Hair by Annie (Annie Nguyen) are separate businesses.
  - If booking both hair and makeup, you will receive and be required to pay separate invoices.
  - Invoices are available upon request.

- All PR/collaborations must be agreed upon in writing via email and signed by both parties.

  - Raw footage remains the intellectual property of Alex Bronwyn MUA.
  - Collaboration deliverables are to be completed within 3-6 weeks, unless otherwise arranged.
  - If Alex is unable to fulfill an agreement due to illness or emergency, a refund will be issued, and products returned.
  - Social media bullying or abuse will not be tolerated. Abusive users will be blocked and reported.
  - All PR/collab payments are final and non-refundable.
